Fees for Antenatal Care and Delivery as a Private Patient

This document outlines the fees that will apply to your antenatal care, labour and delivery. The total cost will vary depending on the number of antenatal visits, the type of delivery, and whether or not you are privately insured. These fees are a reflection of the professional services provided to you by Dr Tan, the costs of running a practice and the high cost of Medical Indemnity Insurance.

First Visit and Antenatal Visits

Your first visit will be a long consultation (item 16401). You would usually expect to have around 12 additional antenatal visits (item 16500) with Dr Tan with payment required at each visit. You may also have visits with our Midwives at no charge to you. No rebate from your private health fund is applicable for visits in the doctor's surgery; however the Medicare Safety Net will result in you receiving some rebates in addition to the standard Medicare rebate once you have reached your threshold in the calendar year.

If you are **admitted to hospital** as a private patient during your pregnancy, your health fund will be billed. **An amount equivalent to the Australian Medical Association (AMA) fee will be charged if you do not have private hospital insurance.**

Dr Tan tries his very best to attend each of his patient's deliveries, however he cannot be available 24/7 365 days of the year. Dr Tan may not be available at the time of your birth due to illness, an unexpected emergency or being in theatre. Your delivery will be managed by the midwives at Calvary John James and the Obstetrician that is on call at the time.

Delivery and Post-Natal Care

If you are privately insured, the fee for your delivery and confinement will be billed to your health fund. If you are uninsured you will be charged directly. *If you are uninsured and Dr Tan is not available at the time of your delivery, the fee for labour & delivery could be different from above, as each obstetrician has their own set of fees.*

****Please note that Dr Tan delivers private patients in a private hospital (Calvary John James Hospital) ONLY****

For Insured and Uninsured patients, please note: If you require an operative delivery such as a Caesarean section, you should also expect to receive accounts from:

- **The Anaesthetist**
- **My Surgical Assistant**
- **A Paediatrician**

Pathology costs

The preferred pathology centre used by our practice is Capital Pathology. Capital Pathology is a privately run laboratory and generate their own invoices. Any pathology requests and/or collections done in our practice are sent to Capital Pathology and will likely incur a fee. If you would prefer to use another pathology centre, you are welcome to take the request form to the laboratory of your choosing.
